### **Friends of the SAAF Museum - Membership Information**

Each member, on joining the Friends, receives a Membership Card which, during its validity period, entitles the member to admission at the relevant AFB (subject to the normal SAAF Security and rules).

### **POPI Act: Protecting members personal information**

The personal information the Friends collect is used to process an application for membership of the Friends, to give us an indication of your skills and interests, and to allow us to stay in contact with you. We collect the information directly from you when you apply for membership, and do not collect unnecessary information. Becoming a member of the Friends indicates that the member has opted into the Friends holding the member's personal information.

The Friends uses a variety of security measures and technologies to help protect this personal member's information from unauthorised access, use, disclosure, alteration, or destruction in line with applicable Personal information protection and privacy laws.

The transmission to the Friends of information via the internet or a mobile phone network connection may not be completely secure, and any transmission is at the member's risk. Despite the security measures that the Friends have in place to protect members' information, the member acknowledges that it may be accessed by an unauthorised third party, e.g., because of an illegal activity.

### **Mission and Vision:**

The Friends of the SAAF Museum comprise aviation minded people who have an interest in the conservation of both the history of the SAAF and its aircraft, including vintage, civilian and military aircraft from around the world. We always uphold the good name of the SAAF and pledge support and assistance in all aspects of museum operations.

### **Museum Duties (check with your local chapter for more detail of when the local museum is operational):**

The Museum is open to the public some days during the week and on these days is manned by SAAF Museum personnel. On the weekend days and public holidays when it is open, the Museum is manned by volunteers from the Friends. Each member is required to do duty on a rotational basis. New members are required to attend Museum Guide training before doing such duty.

### **Socials:**

Social meetings take place once a month (contact your local chapter of the Friends for the dates). At these meetings we discuss all manner of aviation news and history, discuss plans for upcoming duties and Museum related work, listen to aviation lectures or experience presentations by different speakers, socialize and enjoy food, beverages, etc. Annual social gatherings are also held to celebrate the year end.

### **Work Parties and Projects:**

To succeed in our vision and mission, and to meet our commitment to the SAAF Museum, members are expected to be actively involved in regular monthly work parties and/or projects using their talents and skills. I, \_\_\_\_\_, hereby acknowledge that I have taken note of the provisions of section 85 of the Defence Act, 2002 (Act No. 42 of 2002).

**85 Exclusion of liability**

(1) Neither the State nor a member or employee is liable (except in the case of any willful act or omission on the part of a member or employee) to any person who makes unauthorised use of any vehicle, aircraft or vessel under the control of the Department, or to any dependent of such person, for any loss or damage resulting from any bodily injury, loss of life or loss of or damage to property caused by or arising out of or in any way connected with the use of such vehicle, aircraft or vessel.

(2) Neither the State nor a member or employee is liable (except in the case of any willful act or omission on the part of any such person) to any person-

- (a) Referred to in section 80 (3) who makes use of any vehicle, aircraft or vessel which is under the control of the Department and appropriated for use by members or employees;
- (b) Who makes use of any other property of the Department; or
- (c) to whom services are rendered by the Department, or to any dependents of such person, for any loss or damage resulting from any bodily injury, loss of life or loss of or damage to property caused by or arising out of or in any way connected with the use of any such vehicle, aircraft or vessel, such other property or such services.

(3) If the State has paid any compensation in respect of a claim by any person for any loss or damage contemplated in subsection (2), the State may, without having obtained any formal cession of the right of action, recover from the person responsible for the loss or damage, the amount paid by way of compensation or any lesser amount determined by the Minister with the concurrence of the Minister of Finance.

**Furthermore, by entering the premises of the SAAF Museum or participating in any events involving the SAAF Museum, the person attending agrees to the following (and in the case of minors, the guardian of the minor agrees to the following):**

- 1. The SAAF Museum Building Fund, SAAF Museum Fund, or any of its members, officials, employees, volunteers, guests or persons associated therewith shall not be held liable for any personal injury or loss, damage to any property, or losses or injuries to any persons or property under the control of the person signing this indemnity.
- 2. You waive any claims that you may have or may have (now or in the future) against the SAAF Museum Building Fund, SAAF Museum Fund or any of its members, officials, employees, volunteers, guests or persons associated therewith in so far as such claims relate to you, your dependents, spouse, life partner or any other person upon whom you may depend for an income or maintenance, or whom you may be liable to support, whether such claims arose due to negligent, grossly negligent or willful acts or omissions or any other grounds.
- 3. You indemnify the SAAF Museum Building Fund, SAAF Museum Fund and any of its members, officials, employees, volunteers, guests and persons associated therewith against any claim that may arise against them and that has come about due to you, your dependents, your guests or any person under your control's actions or omissions, whether such claims arose due to negligent, grossly negligent or willful acts or omissions or any other grounds.
